### 4. FIRST AID MEASURES

## 7. HANDLING AND STORAGE

<b>Handling:</b>	Wear protective equipment to prevent contamination. Avoid eye contact and repeated or prolonged skin contact. Avoid inhalation of vapour, mist or aerosols.
