# Organic Mag Super™

Highly soluble, free flowing Magnesium powder fortified with Boron & Manganese for deficiency correction in orchard crops on alkaline soils.

#### HAZARD CLASSIFICATIONS:

6.8B, 6.9B

#### WARNING:

Suspected of damaging fertility or the unborn child. May cause liver or kidney damage through prolonged or repeated exposure.

#### DIRECTIONS FOR USE:

- Fill the spray tank until three quarters full with water and then, whilst agitating the spray tank, add the product via the top filter. Continue agitation until application complete. Always apply diluted or mixed chemicals immediately, do not store.
- Tank mixing or co-application. Read all labels carefully and adhere strictly to instructions on mixing. Apply to small test area only when using unfamiliar products or new crops.
- Organic Mag Super should be applied in low light conditions in the morning or evening or on cloudy days. Do not apply during periods of high sunlight, heat, during rain or prior to expected rain.
- Where a deficiency is severe, additional applications may be required.
- Poor water quality may reduce the effectiveness of the product, the solubility of the product and/ or increase the potential for phytotoxic effects on plants.

#### APPLICATION RATES:

Crop	Rate per ha	Min water rate per ha	Recommendations
Grapevines	10kg	500L	Apply 2-3 times, 20-30 days apart, beginning at cap fall.
Pome Fruit	15-20kg	500L	Apply as required at least 10-14 days apart, from 4 weeks after petal fall.

#### STORAGE AND TRANSPORT:

Store locked up in a cool dry place away from foodstuffs. Do not carry more than 10kg on a passenger service vehicle.

#### SAFETY DATA SHEET:

A Safety Data Sheet should be available at all work places where Organic Mag Super is stored or used (available from Grochem or [www.grochem.co.nz](http://www.grochem.co.nz)).

#### COMPONENTS:

Magnesium 9.4%, Manganese 0.75%, Boron 0.3% (as Boric Acid 17g/kg), and Sulphur 13% as water soluble powder.

#### HANDLING ADVICE:

Repeat long term exposure may cause health issues. Avoid exposure while pregnant. Use good hygiene practices. Wear gloves and face protection. DO NOT breathe dust or spray. DO NOT eat, drink or smoke while using this product. Wash hands and exposed skin thoroughly after handling. Use only outdoors or in a well ventilated area. DO NOT handle until all safety precautions have been read and understood. This product MUST NOT be used for any purpose or any manner contrary to this label.

#### FIRST AID:

If exposed, concerned or if symptoms persist, get medical advice/attention.  
IF SWALLOWED: Call a POISON CENTRE or doctor/physician if you feel unwell. Rinse mouth.
