DIRECTIONS FOR USE:

Spray Aid is a water soluble, non-ionic spreader-activator for use in improving the effectiveness of foliar applied plant growth regulators or streptomycin. The addition of Spray Aid minimises the differences in NAA absorption resulting from different environmental conditions and enhances the uptake under conditions normally unfavourable for adsorption.

APPLICATION RATES: The use of Spray Aid will range from 65mL to 250mL per 100L of spray solution. Always follow the label directions for the product being used.
