**DIRECTIONS FOR USE:** Kiwi Finish has been specifically formulated as a foliar feed to supply high levels of plant available nutrients for supplementary feeding to ensure top yields and performance. It is designed to be absorbed by the plant foliage and will not burn or scorch plant growth when applied at recommended rates.

**Contains the growth stimulant TRIACONTINOL.**

**Water rates:** Adequate water coverage is an essential component of effective foliar spraying. With all Grochem foliars we recommend a minimum of 100 litres of water per hectare via conventional ground spraying equipment or 60 litres per hectare via aerial spraying.

#### MIXING INSTRUCTIONS:

1. Add one quarter of the spray water to the tank and begin agitation.
2. Either pre-dissolve the powder in 5 times its volume of water or add to the inlet screen and wash into the spray tank with the remainder of the water.
3. Add any trace elements next, starting with solids, then dispersion and finally solutions.
4. Lastly add any chemicals.
5. Apply immediately. Do not store mixed chemicals.

**Note:** Where a product datasheet specifies that the products should be added in a different order than above (e.g. Copper Hydroxide) then follow those instructions. If in any doubt about compatibility or unfamiliar chemicals are being used then a trial mix is recommended.

#### APPLICATION RATES:

CROP	RATE PER HA	DIRECTIONS
Kiwifruit, Citrus, Avocado, Grapes, Pipfruit, Stonefruit	3-5kg	Apply every 10-14 days as part of a foliar programme.
